This DECLARATION OF TRUST is made this 12th day of October One Thousand Nine Hundred and Ninety Two by:-

2. Smt. Mohinder Kaur w/o S. Raja Singh, resident of B-47, Greater Kailash, Part-I, New Delhi,

4. S. Kawaljit Singh s/o S. Raja Singh, resident of B-47, Greater Kailash, Part-I, New Delhi,

hereinafter called "The Trustees";

WHEREAS the Trustees have collected the sum of Rupees One Thousands/Rs.1,000/- through Public donations to hold upon trust and for the ends, intents and purposes hereinafter mentioned.

NOW THIS DEED WITNESSETH AS FOLLOWS :-

1. The Trustees do by these presents declare that they shall hold and stand possessed of the said sum of Rupees One Thousand and any donations, property, effects or contributions received by them hereafter and all accretions thereto and thereof and the investments including immovable property and securities and from time to time representing the same (the assets for the time being of the Trust being hereinafter referred to as "the Trust Fund") upon the ends, intents and purposes of the trust and with and subject to the powers, provisions and declarations hereinafter mentioned and declared and concerning the same.

1. The name of the trust will be GRD Educational Trust and the head office of the trust will be at E-297, Jangpura Extension, New Delhi-110 014.
2. The objects of the Trust are entirely educational, namely founding and administering a series of schools and colleges and incidentally giving scholarships and educational assistances.

- 10. i) The number of Trustees shall be not less than three nor more than seven.
- ii) The Trustees appointed under these presents shall have power to appoint additional Trustees provided however that the total number of the Trustees at any time shall not exceed seven.
- iii) The Continuing Trustees may act notwithstanding any vacancy in their body provided however that if the number of Trustees shall fall below the minimum fixed as above the Trustees shall not except for the purpose of filling any vacancy act so long as the number is below the said minimum.
- iv) All questions arising at a meeting of the Trustees shall be decided by a majority.
- 11. Any Trustee may delegate in writing all or any of his powers under these presents to his nominee being a trustee who will be entitled to exercise such powers in the same manner as the Trustee himself could do personally.
- 12. The Trustee may delegate any of their powers in relation to any affairs of the trust, school, college to any manager, secretary or committee consisting of such person or persons whether members of their body or not as they may in their absolute discretion think necessary.
- 13. Notice of any meeting of the Trustees and all communications may be sent to the Trustees at their address registered for the time being in the records of the Trust.
- 14. Meetings of the Trustees shall be held at such times and places as the Trustees may from time to time decide.
- 15. If and so often as any of the Trustees hereby appointed or may be appointed in future disclaims, dies, or is for a continuous period of two years absent from India or leaves India for the purpose of residing abroad or is declared an insolvent or desires to retire to be discharged from the Trust or refuses or become unfit or incapable of acting in the Trust or is found guilty of any criminal offence involving moral turpitude a new trustee may be appointed in his place by the surviving or continuing Trustees or Trustee for the time being or if there shall be no surviving or continuing Trustees or Trustee then by the retiring Trustees if they all retire simultaneously or by the last retiring trustee as the case may be .
- 16. Every Trustee will be at liberty to resign on giving one month's notice of his/her intention to do so.
- 17. The Trustees may from time to time make such rules and regulations not inconsistent with the objects of the Trusts for managing the affairs of the Trust, as they may think fit and may from time to time add to alter rescind and vary the same.

- 18. It is expressly declared that no part of the Trust property or its income or Trust Fund shall be applied for any purpose outside India or for any purpose which is not an educational purpose in law and all provisions hereto shall be construed accordingly.
- 19. In the event of dissolution of the Trust from any cause whatsoever, all its funds, property and assets of all kinds shall be delivered at the earliest convenient opportunity or opportunities to such institution or institutions or trust or trusts in India whose purposes and objects most closely resemble the purposes and objects of the Institution.
